Subsidy

During July, your family should be receiving a letter in regards to your child (ren)'s subsidy. Our team will work with any families who wish to submit a request for review and renegotiation of subsidy during the month.

What signifies a need for change in review and renegotiation of subsidy?

Below are a few examples of what may be the reason.

1. The child develops new behavioral issues as a result of trauma that the child endured before adoption
2. New medical or mental health diagnoses
3. Continued issues or behaviors that have intensified since the adoption
4. Continued impairments to child's physical, emotional, or mental health
5. Change in family circumstances due to job loss or relocation to another state

Keep in mind if you think your family needs to renegotiate the subsidy, please reach out and ask to speak with one of our team members. Our team will work with you and your family to complete an individualized assessment of need, review and document discrepancies between the current needs, and submit a finalized recommendation to the Department's permanency supervisor for evaluation and review. We are here to walk you through the process and ensure you are feeling supported.



Grants

Did you know that there is a grant specifically available for post-permanency families? If not, here is some basic information about it! Please feel free to reach out with any additional questions or information requests!

Who is eligible for these grants?

- The adopted or guardianship child must be under the age of 18
 - Must have been adopted through foster care, private, independent, or intercountry adoption in any state (***excludes stepparent or birth parent adoption***)
 - Must have been placed in a legal guardianship through the child welfare system in any state
- The child must have a current need related to one of the following best interest factors:

- emotional/behavioral needs
- cultural/religious needs
- educational/developmental needs
- medical/physical needs
- Trauma-related needs
- Relationships with parents, relatives, siblings, and current caregivers
- Child's interests and community connections
- Documentation of the identified need(s) will be gathered in an assessment with IARE's staff

What can the grant be used for?

Services, activities, or supports related to the child's identified needs which are:

- One time or time-limited
- Not covered under other programs or community organizations
- May include assistance meeting basic household needs in the event of a financial crisis that may be threatening the stability of permanent place
- May include services or supports for birth children in the home ONLY if those services or supports are necessary to meet the needs of adopted children.

Additional Examples:

- Transportation expenses to maintain connection birth families
- Time-limited in-home counseling or family/sibling counseling
- Parent registration, travel fees, and child care for training to meet the child's needs
- Time-limited therapies not covered by Medicaid/EPSDT/Private insurance (i.e. Equine or art therapy)
- Specialized summer camps/activities

What is excluded?

- Residential Services
- Out of home placement
- Orthodontics
- Attorney/Court fees

Is there a limit of times a family can utilize a grant?

Grants being awarded are dependent on the availability of funds. There is no limit to the number of requests that a family can make, however, priority may be given to families who have not been awarded a grant.

Child Tax Credit

Were you aware that the American Rescue Plan included a historic Child Tax Credit? The plan includes benefits for nearly all working families, including those who, due to their low income are not required to file federal taxes.

In a move to help families struggling to make ends meet, the Biden administration is encouraging all eligible families who were not required to file a 2019 or 2020 individual tax return due to their low-income status to now sign up for these monthly benefits set to begin in July.
